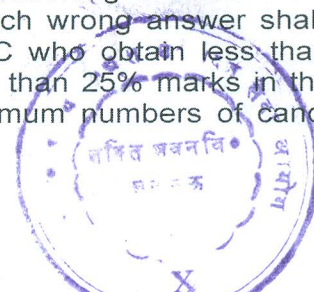

- Examination Centre & Selection Process**

**(a) for post code 5 to 11:-**

Selection Processes for above posts will be based on written Test (Computer Based Test) CBT and documents verification. Computer Based Test (CBT) will be held at Ghaziabad, Gorakhpur, Kanpur, Lucknow, Meerut & Varanasi Cities. U.P. Rajya Vidyut Utpadan Sewa Aayog. however, have the right to cancel any of the Examination city/Center and/or add some another Cities/Centers depending upon the requirement, administrative feasibility, or any force-majeure conditions etc.. The test shall be of objective type of total 200 marks and shall comprise of total 200 questions, out of which 150 questions shall be from the minimum qualification level for the relevant post applied and 50 questions of General Knowledge/Awareness, Reasoning and General Hindi. Each correct answer shall carry one mark each and each wrong answer shall carry negative mark of 0.25. Candidates of Un-Reserved/OBC who obtain less than 30% marks in CBT and SC/ST candidates who obtained less than 25% marks in the CBT will not be eligible to be considered for selection. Maximum numbers of candidates



short listed will be 1.5 times the number of vacancies. Qualifying candidates with same marks in CBT at bottom will be counted as one for shortlisting purpose only. Appearing in the CBT and documents verification is compulsory; failing which candidature will be treated as cancelled. Finally, the merit list shall be prepared on the basis of the marks obtained in the CBT.

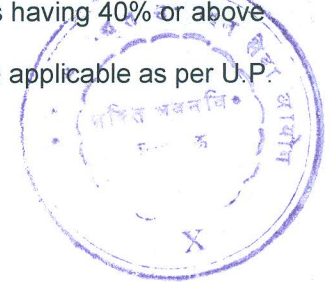

6. **BOND:-**  
The amount of Rs. 2.00 lacs for the post of Junior Engineer and Technician grade-II for the period of 5 years shall have to be submitted at the time of joining by the candidates.

7. **PLACEMENT:-**  
The selected candidates for the post of Junior Engineer(Trainee) shall undergo for minimum one year training at site on Head Quarter wherever they have been posted. They shall be posted at a location within the Nigam after successful completion of training. The job however is transferable. Successful Candidates (JE(T) & TG-II) during their service tenure, can be placed in any of the functions at any Hydro Electric Project i.e. Rihand, Obra, Matatila & Khara/Corporate office of the Nigam or at positions in the joint venture & subsidiary companies of UPJVNL in accordance with the rules & regulations of UPJVNL.

**Relaxation:-**

- (a) Period of apprenticeship training or 01 year (Whichever is less) in upper age limit to the candidates who have undergone apprenticeship training under apprenticeship act 1961.
- (b) 05 years in upper age limit to the SC/ ST & OBC (Non-creamy layer) who are Original inhabitant (Domicile) of Uttar Pradesh. Candidates of these categories but non resident of Uttar Pradesh shall be treated as **un-reserved (UR)** for all purposes.
- (c) 15 years in upper age limit to the handicapped candidates having 40% or above disability.
- (d) Age relaxation for Ex-Service/Ex-Army personal shall be applicable as per U.P.



Govt. Rule.

9. **RESERVATION:-**

- (i) A candidate must be original inhabitant (Domicile) of UP to avail the reservation benefits. Candidates of SC/ST/OBC(Non Creamy Layer)/DFF/PH but not resident of UP shall be treated as unreserved(UR) category for all purpose.
- (ii) SC/ST & OBC (Non- Creamy Layer) candidates who are original inhabitants (Domicile) of Uttar Pradesh shall be considered for reservation under these categories as per state government rules.
- (iii) 02% Horizontal reservation for dependents of freedom fighters (DFF) shall be applicable as per State Government rules.
- (iv) 05% Horizontal reservation for Ex-Servicemen/ Ex-Army personnel for the post of JE(T) and TG-II shall be applicable as per U.P. Govt. rules.
- (v) 3% Horizontal reservation for Physically Handicapped(OA/OL,PB,PD) candidates for the post of JE(T) E&M cadre shall be applicable as per U.P. Govt. rules
