7. Syllabus for Examination.

(a) General Intelligence & Reasoning. The questions will be of Matriculation standard and would include questions of non-verbal type. The test may include questions on analogies, similarities and differences, space visualization, problem solving analysis, judgment, decision making visual, memory, discrimination, observation, relationship concepts, figure classification, arithmetical number series, non-verbal series. The test will also include questions designed to test the candidate's abilities to deal with abstract ideas and symbols and their relationship arithmeticalcomputation and other analytical functions.

(b) General Awareness. The questions will be of Matriculation standard.
