- (b) Should have been an active member of a Scouts organisation for the last 5 years. The 'Certificate of Activeness' should be as per Annexure-I (enclosed);
- Should have attended two events at National Level or All Indian Railway's level and Two Events at State Level

Explanatory Note:

- @ Atleast Five years in the recent past i.e. during 2015-16, 2016-17, 2017-18, 2018-19, 2019-20 and should continue to be active, i.e during 2022-23 (till date).
- Certificate should contain the 'List of Events attended by Candidate'

Act Apprenticeship / ITI. No other qualification including Diploma in Engineering will be accepted as an alternative qualification. Act Apprenticeship / ITI Certificate must be approved by SCVT/NCVT. (Authority: RBE No. 13/2019).
