

their present employer during the time of interview. However, they should submit an undertaking with their application that the NOC would be submitted at the time of interview. Application from such candidates without undertaking will not be entertained.

- 15. The online applications received in response to this advertisement shall be scrutinized as per the eligibility criteria detailed in the advertisement. The Scrutiny/Shortlisting Committee may formulate additional criteria for short listing, based on academic performance and/or years of experience and/or through trade- based test/examination of the applicants with the approval of the competent authority of the Institute. Only shortlisted candidates will be called for selection process.
- 16. Merely fulfilling the eligibility criteria does not entitle a candidate to be called for written test/interview. In case the number of applications received is large, Institute reserves the right to raise the minimum eligibility level in order to restrict the number of candidates to be called for interview, commensurate with the number of vacancies. The decision of IIT Goa in this regard shall be final.
- 17. The age limit shall be 57 years across all the cadres up to Pay Level 14 for regular employees of the Institute.
- 18. The age limit criterion will be relaxed for applicants working in any department / section / unit /project of the Institute provided they have served the Institute for at least three years (220 days or more per year) and who have crossed the age limit criterion during the above period.
- 19. The certificates of work experience should be in proper format i.e. it should be on the organization's letterhead, bear the date of issue, specific period of work, salary, name and designation of the issuing authority along with their signature and stamp.
- 20. For Group-C (Technical) and Group-B (Technical) categories of posts, the applicants shall be required to pass a test of proficiency/skill in the relevant discipline. Final selection will be made on the basis of written test subject to qualifying test of proficiency. The Selection for other Group A posts shall be made through a screening/written test and/or Interview of eligible short-listed candidates (based on screening/written examination).
